## SUBMISSION OF ENTRIES

Download and fill-out the entry forms using a pdf reader or open within your web browser. If you are using Adobe Reader use the "save as" function under "file" and save as a pdf. If you are using a web browser, you may instead use the "print" function pull-down under "file" and save as a pdf. If you are using a tablet or your phone to complete your entry please download and use the Adobe Reader Ap. There are two files. One is the "NHSPRING2019ownerinfo" file. Complete this form and save with the file name "NHSPRING2019 yourlastname".

Reopen the saved file to verify that your information was indeed saved. Use the "NHSPRING2019doginfo" file to enter your dogs. If you are entering more than two dogs you will need to complete two copies of this file. Name the completed form(s) as "yourlastnameNHSpring2019dogname(s)". **We strongly encourage the submission of digital entries using the fillable pdf forms** (visit your local library if you cannot do this from home). If you are unable to fill out the forms digitally, please print them, complete them legibly with a pen and mail them to the show secretary. Do not attempt to create a digital file with your cell phone camera. The resolution is poor and the text difficult to read.

## NOTICE TO EXHIBITORS

**Entry fees shall not be refunded** in the event that a dog is disqualified, excused, or barred from competition. If, because of riots, civil disturbances or

other acts beyond the control of the management, it is impossible to complete the shows, no refund of entry fee will be made.

**Returned checks** do not constitute a valid entry fee. The IWC will add a \$25.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.

**All entries will be on official IWC entry forms. Entries not on official IWC entry forms, or photocopies of entry forms** without the Agreement and Rules on the reverse side of the Official IWC Entry Form, are **not acceptable**.

**Errors on entry blanks.** Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in the event of such errors.

Time of judging is printed in this Premium List. No further Judging schedule will be mailed. No Judging Program will be mailed for this event.

**Dogs need only be present** for scheduled judging and will be released if not needed for further judging. IWC will not be responsible or obligated to furnish any service through a public-address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**Judges need not wait** for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.

**All dogs present** must be held on leash or confined to their crates except when being judged.

**IWC will use due care** and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors, or their families participating in this show, and further assumes no responsibility for injury to children.

**Note** – IWC is not responsible for lost or stolen articles. Please check your grooming area before you leave.
